Dear Flemington-Raritan Regional School District Parents, Staff, and Community Members,

As Spring Break approaches, it is critical to avoid unmasked close contact and to continue to follow [quarantine recommendations in New Jersey's travel advisory](#). Taking all precautions and following recommended guidance helps to ensure the continuation of in-person instruction and middle school athletics. Increases in transmission may jeopardize our ability to keep our doors open for students due to the number of staff, faculty, and students that need to quarantine. To date, we have not stepped backward and we do not intend to halt in-person instruction however, we are watching the data closely.

Along with the state and region, Hunterdon County is reporting an increase in COVID-related activity. The number of positive cases reported in Hunterdon County is increasing. In the last 7 days, the average number of cases reported per day is 53, compared to 43 cases per day the week prior. The percentage of positive test results in Hunterdon County is increasing, currently 11.51%. Over this past weekend, the Department of Health received a notable increase in school-related calls reporting positive students, staff, and clusters of illness.

Over the weekend, the District received notice of nine positive COVID-19 cases district-wide. The location and last day in the building for each case is outlined below. All instances required contact tracing.


- Copper Hill School: 1 staff member, March 25.
- Francis. A. Desmares School: 1 student and 1 staff member, both on March 24;
- Robert Hunter School: 1 staff member, March 24;
- Reading-Fleming Intermediate School: 2 staff members, March 24 and March 25;
- J.P. Case Middle School: 3 students, March 22, March 24 and March 26.

Our District nurses follow all contact tracing guidelines from the Department of Health. We are not able to share any other identifying information about positive cases due to the [Health Insurance Portability and Accountability Act \(HIPAA\)](#). Whenever contact tracing determines that your child or a member of our staff or faculty has been in contact with an ill person, our district nurses will communicate guidance to all those that are determined to need to quarantine. This process starts immediately with the reporting of the case. We continue to have staff, faculty, and students that must quarantine due to positive cases. Please remember to wear a mask, wash your hands, practice social distancing, and follow all health and hygiene recommendations. The goal to keep our school doors open for our community requires that everyone take precautions to slow the spread of COVID-19.

The district follows recommendations from the New Jersey Department of Health. While COVID activity in Hunterdon County remains high, schools should continue to exclude staff and students if they have:

- Tested positive (viral test) for COVID-19 - Confirmed cases of COVID-19 should stay home until at least 10 days have passed since symptom onset and at least 24 hours have passed after the resolution of fever without fever-reducing medications and improvement in symptoms.
- COVID-19 compatible symptoms - All individuals with COVID-19 compatible symptoms who have not been tested should stay home until at least 10 days have passed since symptom onset and at least 24 hours have passed after the resolution of fever without fever-reducing medications and improvement in symptoms. An alternate diagnosis (including a positive strep test or influenza swab) without a negative COVID-19 test is not acceptable for individuals who meet COVID-19 exclusion criteria to return to school.

- Potential exposure to COVID-19- Close contact with a person with COVID-19 in the past 14 days require an exclusion period based on Regional Risk levels. When the region is **“High”** (orange) exposed close contacts should be excluded from school for 14 days. **“Moderate or Low”** (yellow or green) exposed contacts should be excluded from school for 10 days (or 7 days with negative test results collected at 5-7 days using a “viral test” otherwise known as a PCR test or molecular test, not a diagnostic test such as the rapid antigen test.) Currently, our region is “High” (orange). According to the Hunterdon County Health Department, when our region is in the High COVID activity level, the 14 day quarantine time frame is recommended. Any deviation of the 14-day quarantine recommendation is evaluated on a case-by-case basis and only considered if the 14 days are not feasible due to extenuating hardship. Until we see a different trend in the number of cases, a decrease in the COVID-19 activity level index reports, we will take the safest route to keep our doors open to students, staff, and faculty, and exclude those who are exposed. [The CDC and the NJDOH continue to endorse 14 days as the preferred quarantine period](#)—and thus the preferred school exclusion period. Questions should be directed to the school nurse.
- Engaged in domestic and/or international travel in the past 10 days (exclude in accordance with NJ Travel Recommendations and essential employees).
- Siblings of a student who has symptoms and meets COVID-19 Exclusion Criteria should be excluded from school until the symptomatic individual receives a negative test result. If the symptomatic individual tests positive, the sibling is required to self-quarantine.
