CITIZENS ADDRESS THE BOARD

Mr. Davidson stated that, "we have a group of people who are interfering with the ability of the Board to provide a confidential environment for the Superintendent Candidates that we are interviewing tonight. It is very important that their identities remain private at this time for most of them are actively working and their districts do not know they are looking elsewhere. Should that information become public, their careers could suffer damage. This is a major reason why the identity of these candidates should remain private. Our ability to keep it that way is being interfered with by an action of the FREA who have come to this meeting and lined the halls with a gauntlet of personnel so that any candidate entering or leaving will be seen. The FREA has done this actively by checking the exits in the school and having them covered. This action will only hurt them, the district and our students. We are seeking to find the finest Superintendent we can to administer this district. This is to the benefit of everybody including the Union, the Teachers and the Administrators, EVERYONE! Interfering in that process only hurts us all. So I deplore this action that is being taken tonight and encourage them not to repeat this or interfere with the process of finding them the finest Superintendent that we can".

On the motion of Ms. Fallon, seconded by Mr. Liszt, the meeting was adjourned, unanimously viva voce, at 5:12 p.m. to executive session in Room D111.
