# FLEMINGTON-RARITAN REGIONAL BOARD OF EDUCATION REGULAR MEETING January 9, 2012 MINUTES

The regular session of the Flemington-Raritan Regional Board of Education was called to order in conformance with the "Sunshine Law" by Patrick Larmore at 7:01 p.m. in the Auditorium at J.P. Case Middle School.

On the motion of Dr. Bonieski, seconded by Ms. Behn, minutes of the Regular Meeting on December 19, 2011\* were approved viva voce. \*Ms. McGivney abstained.

#### CITIZENS ADDRESSED THE BOARD

Robin Smith, FREA President, recognized last year's Teacher of Year. She noted that the Board of Education gave no recognition.

Dan DeCanio, Vice President, FREA, noted teachers pay more for benefits and the Board of Education makes tough decisions.

Scott Totten, Teacher, noted Mr. Zarish asked about researching for a new auditor and expressed concern that we pay so little for an audit.

Linda Alsop, taxpayer, Raritan Township, Teacher, shared her daughters success stories as students of the Flemington-Raritan School District. She spoke about the environment students need to learn and teachers need to work. She asked that the contract be settled.

Vanessa Ahmed, Teacher, noted how wonderful this district is. She asked the Board and Administrators to value the expertise the teachers bring to the school. She asked leaders to improve the climate and therefore the performance.

Judy Mandell, Teacher, thanked the Board of Education for looking at those speaking.

Linda Brown, Teacher, shared the CPI rate with the Board of Education for December 2011 and noted many of the rates are increasing.

Sue Vala, Teacher, spoke about a speech she read 15 years ago. She noted that she could use it again today. She asked the Board of Education to consider what they need to run their household. She is concerned that teachers have to beg for what she feels is right. She asked the Board "why do you put us last"?

Laura Lucchetto, Teacher, shared that she has a passion for teaching, but it's very tough being a teacher with all of these stresses.

Kathy Scheffels, Teacher, shared her personal and professional commitment to this community and our students. She truly cares about our students. She stated that the Teachers ask that they are recognized, respected and compensated.

Lori Gerry, Teacher, spoke about how many years she has been in this district and that she was overlooked for 25 years. Mr. Nolan did correct the error but still felt invisible. When she was asked by others if they should become teachers, she has a tough time saying yes. She will need to have a second job; it is no longer financially enough.

Ellen Rogers, Teacher, spoke about the work she does and the reasons she became a teacher. She asked the Board of Education to settle the contract. She noted that the teachers are not your enemies. She also thanked the FREA negotiations team for all of their work.

Robert Jones, Teacher, asked how we paid bus drivers on January 2 since the calendars are not the same with Hunterdon Central. He asked about the mold update at Robert Hunter as he thought the test results came back.

Aileen Marsh, Teacher, stated she is getting frustrated that the leadership is not respectful, and they are only asking for an agreement and to be treated fairly.

Ms. Foreman gave a negotiations update. She noted next Thursday, January 19<sup>th</sup> at 6:00 p.m. is Fact Finding. The Fact Finder will issue a written report. His recommendation is not binding. The report will be forth coming, hopefully within 3 or 4 months. The report will be public.

Mr. Nolan made a statement expressing the value and appreciation for you as teachers. He also thanked them for the professionalism they showed tonight.

#### **POLICY**

- 1. Approval was given for the Facility Use Agreement with the Flemington-Raritan Youth Basketball Association for the 2011-2012 school year, as attached.
- 2. Approval was given for the presentation of the following new policies for 2<sup>nd</sup> reading:
  - 5519 Dating Violence at School Mandated

Dating violence legislation, P.L. 2011 Chapter 64 was recently signed requiring school districts to have a policy to prevent and respond to incidents of dating violence at school.

The new law takes effect for the 2011-2012 school year and required the NJDOE to establish a task force to develop policy guidance. The NJDOE published its policy guidance on September 19, 2011.

Strauss Esmay Associates developed Policy and Regulation Guide 5519 that incorporates the requirements of the new law and the policy language recommended in the NJDOE Policy Guidance. The Policy Guidance recommends certain language be included in the district's Policy that we typically include in a regulation as this language is more about procedure than Policy statements. We included these provisions in the new Regulation Guide and to be in compliance with the statute, we are requiring this Regulation Guide be a regulation that requires Board approval. The new law requires each school district/charter school to approve a policy to prevent, respond, and educate their pupils, as well as their school community, on acts or incidents of dating violence.

The Board's policy and must comply with the minimum requirements stated in the legislation in regards to the prevention, response, and education of their pupils in regards to incidents of dating violence that occur at school. The policy must contain, at the minimum, the following requirements:

- 1. A statement that dating violence will not be tolerated;
- 2. Dating violence reporting procedures;
- 3. Guidelines for responding to at-school incidents of dating violence;
- 4. Discipline procedures specific to at-school incidents of dating violence;
- 5. Warning signs of dating violence; and
- 6. Information on safe, appropriate, school, family, peer, and community resources available to address dating violence.

These provisions have been incorporated into the new Policy and Regulation Guide and are consistent with the NJDOE's Policy Guidance published on September 19, 2011. The NJDOE and the Policy Guidance state the content and format of local policies and procedures must be developed locally. Therefore, a district may make changes and revisions to this Policy and Regulation Guide that are consistent with the requirements of the law.

The NJDOE Policy Guidance included a list of support agencies and suggested educational resources on dating violence that is included with this Policy Alert. In addition, the Guidance included a suggested Victim Safety Plan, a School-Based Stay-Away Agreement, and a Report Form. We made several revisions to these documents to be specific to dating violence as some of the forms included bullying and sexual harassment. In addition, we developed an Investigation Form. These forms and documents may be modified by a district. The district has the option to use the Victim Safety Plan or a Stay-Away Agreement. The Policy and Regulation Guides have been available for download through <a href="https://www.straussesmay.com">www.straussesmay.com</a> since October 31, 2011. These new Guides with supporting forms and documents are included in this Policy Alert. Each school district must also update their Code of Conduct to include consequences and remedial measures for confirmed acts or incidents of dating violence at school.

#### 6472 - Tuition Assistance - Recommended

P.L. 2010, Chapter 13 (N.J.S.A. 18A:6-8.5) was approved on May 6, 2010 and has a significant impact on tuition assistance and additional compensation paid for a staff member who acquires additional academic credits or completes an advanced degree. The new statute has been the source of much debate and controversy regarding the interpretation of N.J.S.A. 18A:6-8.5.c. that indicates, "The tuition assistance or additional compensation shall be provided only for a course or degree related to the employee's current or future job responsibilities." A district's interpretation and implementation of this provision of the statute should be determined after consultation with the Board and the Board Attorney. Strauss Esmay Associates delayed publishing this Policy Guide anticipating some clarification from the New Jersey Department of Education or a Commissioner's decision challenging a district's interpretation of the provision. As of this Policy Alert there has been no clarification or published Commissioner's decision challenging a district's interpretation.
